This Agreement shall become effective upon the deposit at the address of CO-OPERATIVE INVESTMENT FUND LTD complete with the relevant signatures attached, an initial deposit of not less than \$50.00, in addition to a membership fee of \$50.00 and shall be governed by the Laws of Barbados in all respects, including and without limitation, matters of title, construction, validity performance and discharge, and shall not be waived, altered, monitored or amended as to any of its terms or provisions except those to which CO-OPERATIVE INVESTMENT FUND LTD may specifically consent in writing.
